<u>legal basis of data processing</u>: the declaration of consent corresponding to (1) a) of the Information Law (Infotv)

term of data processing: immediately deleted after the event

method of data storage: paper

data forwarding: to the Armed Security Guard (FBŐ) running the site

**aim of data forwarding:** access control security according to the rules of the Law on Armed Security Guard (Fbötv.)

<u>range of forwarded data</u>: name, maiden name (as under the age of 14, entry to the site is unauthorised), ID card number, or, in case of a foreign citizen, passport number, name of institute/place of work that the person comes from, vehicle registration number (in the event that the person wishes to enter the site by car), contact details, e.g. email address.

legal basis of data forwarding: \$9/B of law CLIX of 1997 on the armed security and ranger guard
